Terms and Conditions

RESERVATION: Reservation are accepted by fax, e-mail, or online. Confirmation is issued only upon our receipt of your deposit.

PACKAGE PRICE/SURCHARGES: Danny Travel Inc reserves the right to re-invoice participant(s) in case of error made in computing our tour prices. All prices quoted are based on airfares and land rates (including hotel prices) that are in effect at the time of request and are subject to change without notice. Tour prices do not include: passport and visa fees, some airports & port charges, excursions and sightseeing tours not mentioned in tour features, meals and beverages not mentioned, excess baggage fees, airport taxes, air supplements, weekend surcharges, extra charges for room occupancy before or after normal check-in/out times, tips, laundry charges, room service charges, and items of a personal nature.

HOTELS: Space is subject to availability. If your requested hotel is not available as a courtesy the tour operator will confirm an alternate and the package rate will be adjusted if necessary. It is the passenger/travel agent's responsibility to notify the operator of acceptance of any alternate hotels within 24hrs of booking. Failure to do so may result in cancellation of services. Rooms are assigned on a run-of-the-house basis by hotel management upon check-in and specific requests (adjoining rooms, rooms with certain views, wheelchair accessible) cannot be guaranteed. Single rooms are usually smaller in size than twins or doubles and have one small bed. Triples are usually a standard twin/double plus a rollaway, or sofa bed. All accommodations are with private bath or shower and include all hotel taxes. Not all hotels, or hotel rooms are air- conditioned. Air conditioning systems may not be equivalent to American standards. We cannot guarantee that the service will be in operation at any given time and cannot be held responsible for any such lack of operation at the time of stay. Hotel check-in time cannot be quaranteed. Standard hotel check in time is after 2pm and checkout is normally required by 11:00 am.

AIR TRANSPORTATION: Based on regularly scheduled service on available carrier of IATA. All applicable airline rules apply. Schedules are subject to change without notice by air carrier and are not under the control of the operator. Failure to check-in at least two hours prior to departure may result in denied boarding, and no refund will be granted. Danny Travel is not responsible for any cancellations, loss, delays, injury, illness or expenses incurred due to actions made by the airlines.

BAGGAGE ALLOWANCE: Passengers are financially responsible for excess baggage fees charged by air carriers or ground transportation providers. International limit is 1 piece for checked and 1 piece for carry-on. Checked Baggage may weight maximum 50lb p/p and max volume of 62 inches. One piece of cabin baggage may weight max 18lb and max volume of 45inches. Due to space limitation on bus or ships, only one suitcase and one piece of hand luggage is allowed.

PASSPORT/VISA: All passengers must have a valid passport at least six months beyond your scheduled travel date. Danny Travel is not responsible for the provision of passports or visas. Please check with the appropriate consulate for details. You are responsible to check all of your documents upon receipt and to verify that they are accurate and complete. Failure to do so may result in additional costs to you.

TIPPING: Tips to Monasteries, Tour and Cruise Directors, drivers, guides, porters, waiters, chambermaids and other ground personnel handling your travel arrangements are not include in your total package cost.

PAYMENTS: We accept major Credit Cards, Bank, Certified or Personal checks, money order or wiring funds. Direct Credit card charges will be accepted if the completed credit card authorization form is received 60 days prior departure. Third-party credit cards are not acceptable. Returned checks will incur a USD 30.00 service fee. Nonrefundable deposit is required at the time of booking in the amount of USD 400.00 per person. A change of date or name or destination after Deposit will be subject to full cancellation fees in the amount of USD 300.00. Full payment is due ten days after booking made 60 days before departure.

Payments received 7 days or less prior to departure will be assessed a USD 45.00 fee before documents will be issued.

CANCELLATIONS/REFUNDS: Once a partial or full payment has been made, cancellations will only be accepted in writing. Cancellation terms will be applied based on the date that the written cancellation is received and based on the following dates prior to departure. Upon receipt of full payment, a minimum penalty of USD 300.00 will apply.

60-46 days prior to departure: 30%, 45 to 21 days prior to departure: 60% of cost, 20 days prior to departure: 100% of cost, No-show: 100% of cost. The value of airline tickets, once issued is non-refundable. We strongly recommended travel insurance.
